Why is it that we often want to change, but find that we are unable to do so? Why is change so difficult even when everyone and everything is aligned around the goal? The reason is that most of us have a built-in immunity to change. This fast paced, energetic and transformational workshop will help participants better understand their own immunity to change.

Based on their research in adult development theory, Robert Kegan and Lisa Lahey have developed an innovative teaching methodology and activity called *Immunity to Change*. This workshop is an awareness-building exercise that makes explicit that which is currently implicit. *Immunity to Change* helps participants better understand their competing commitments and truly begin to understand the motivation behind behavior and why change, with all of the best intentions, can be so difficult to master. Amazingly this session provides participants with the opportunity to “investigate, research, study, teach, practice, and implement the theories and strategies” behind Kegan & Lahey’s work.

Lisa Lahey will guide participants through the *Immunity to Change* process, and participants will complete the “Immunity Map” which outlines some of the motivators behind commitments they hold. In the end, the map clearly outlines why certain behaviors do/do not occur, competing commitments held by participants and those “big assumptions” that drive behavior – assumptions that may limit personal change or block true leadership development.

Leading in Concert will be a special event connected with the 2010 ILA conference. Occurring on the evening of Friday, October 29th, the concert will explore the connection between music and leadership by bringing together artists and performers whose art is motivated in full or in part by a desire to make change. Each artist will speak briefly about how they understand the connection between leadership and their work, and then perform their amazing craft. Over the course of the evening, the audience

will experience thoughtful explorations of the connection between music and leadership as well as a collection of moving and powerful performances.

Leadership in Concert will take place at the beautiful Jordan Hall within the historic New England Conservatory, which is a brief 10-minute walk from the Conference Hotel. “Acoustically superb Jordan Hall is the heart and soul of New England Conservatory and is central to the musical life of New England, with performances by the world's leading soloists and ensembles.” Further, Jordan Hall is also a National Historic Landmark, and it was on the steps of Jordan Hall where it is said that Dr. Martin Luther King Jr. first met his future wife, Coretta Scott.

Confirmed performers include the Boston Children's Chorus and Matimba Ya Ripfumelo. A Boston institution, the Boston Children's Chorus harnesses the “power and joy of music...to unite [Boston's] diverse communities and inspire social change”. Matimba Ya Ripfumelo is “Boston's premier South African vocal ensemble”. Fifteen voices strong with a powerful backing band, Matimba's efforts raise money and awareness for AIDS orphans in South Africa.

Additional performers and details will be announced soon, equating to be a magical night of music and leadership in Boston.
